

APPLES TO APPLES

NATURAL GAS RATE PLANS FOR RESIDENTIAL CUSTOMERS



The Public Utilities Commission of Ohio produces the Apples to Apples chart to provide consumers with a "snapshot" comparison of current supplier price options, contract terms, and an estimated annual total cost. Current Dominion East Ohio (DEO) customer rates are based on the Commission-approved gas cost recovery (GCR) rate, which changes quarterly based on DEO's actual gas costs. Once you choose a natural gas supplier, you become an Energy Choice customer, whose rates are based on the contracted supplier's price. For purposes of this chart, we have calculated estimated annual total costs based on the average annual gas consumption amount of 135 Mcf. Mcf stands for 1000 cubic feet of natural gas. **Your actual cost will vary according to your actual usage.**

Although there may be other approved marketers serving customers in the DEO Energy Choice program, the Apples to Apples chart only lists the approved-marketers that are actively enrolling customers. As with all contracts, consumers should carefully read and understand all terms and conditions before signing any forms or agreeing to enroll with a supplier for gas service. Published price options and contract terms are subject to change without prior notice. Marketers may not be serving all areas of DEO's service territory.

* The Total Rate Column includes the DEO transportation delivery charges for all customers. DEO charges its customers an excise tax of gross receipt on the gas cost recovery rate (per Mcf). Suppliers must, by law, charge customers a sales tax on the amount of gas used (per Mcf). For the purposes of this chart, the gross receipts tax is included in DEO's total rate, but sales tax is not included in the Supplier's total rate, because Ohio sales tax ranges anywhere from 5.5 to 7 percent. See the reverse side for the actual numbers used.

** The Estimated Annual Total Cost column includes the price you pay the supplier for gas used, applicable taxes, DEO's monthly service, and DEO's gas delivery charges you have always paid to DEO for the safe, reliable delivery of gas to your home.

**"How Do I Calculate My
Estimated Annual Gas Bill?"**



Dominion East Ohio Bill

Using the Dominion East Ohio GCR (Gas Cost Recovery) rate of \$8.6990 per Mcf (1000 cubic feet) for a household that consumes 135 Mcf in one year:

GCR Rate \$8.6990 (+) Excise Tax of \$0.4259 = \$9.1249 (x) Gas Usage	\$9.1249/Mcf	x 135 Mcf	=	\$1231.86
Gas Transportation Delivery Service Charge* (+) Riders (x) Gas Consumed (Mcf)	\$1.4277/Mcf	x 135 Mcf	=	\$192.74
Monthly Customer Charge	\$5.70/month	x 12 Months	=	<u>\$ 68.40</u>
Estimated Annual Total Cost:			=	\$1493.00

Supplier "A"

Suppose Supplier "A" offers a fixed rate of \$7.50 per Mcf (plus sales tax) and you consume 135 Mcf in one year. We calculate the estimated annual total costs as follows:

Supplier Rate x Gas Usage	\$7.50/Mcf	x 135 Mcf	=	\$1012.50
Sales Tax (using 6.0%)**	.06	x \$1012.50	=	\$60.75
Gas Transportation Delivery Service Charge* (+) Riders (x) Gas Consumed (Mcf)	\$3.0947/Mcf	x 135 Mcf	=	\$417.78
Monthly Customer Charge	\$5.70/month	x 12 Months	=	<u>\$ 68.40</u>
Estimated Annual Total Cost:			=	\$1559.43

* The DEO calculations above use a \$1.4277 per Mcf gas delivery charge instead of the \$3.0947 per Mcf used in the Supplier A Table. Two different charges are used for the purposes of this calculation because the difference between the two charges (\$1.667) is already built into the DEO gas cost recovery rate that is used to calculate the DEO bill. You pay the same amount for the delivery of your gas whether you are a Choice customer or not.

**This example uses sales tax of 6.00%. DEO pays an excise tax, while suppliers are subject to sales tax.
