On July 19, 2010, NTELOS, Inc. entered into a purchase agreement to acquire 100% of the outstanding equity interests in FiberNet of Ohio, LLC, and its parent company, Mountaineer Telecommunications, LLC. This corporate change of control transaction was formally filed with the PUCO on July 30, 2010 and was docketed as Case No. 10-1063-TP-ACO. This transaction was automatically approved by the PUCO 30-days after filing. Thereafter, a memo closing this case was filed on September 29, 2010

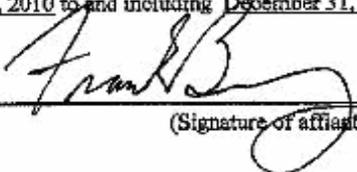
