GENERAL INFORMATION

I. Purpose

FERC Form No. 1 (FERC Form 1) is an annual regulatory requirement for Major electric utilities, licensees and others (18 C.F.R. § 141.1). FERC Form No. 3-Q (FERC Form 3-Q) is a quarterly regulatory requirement which supplements the annual financial reporting requirement (18 C.F.R. § 141.400). These reports are designed to collect financial and operational information from electric utilities, licensees and others subject to the jurisdiction of the Federal Energy Regulatory Commission. These reports are also considered to be non-confidential public use forms.

II. Who Must Submit

Each Major electric utility, licensee, or other, as classified in the Commission's Uniform System of Accounts Prescribed for Public Utilities and Licensees Subject To the Provisions of The Federal Power Act (18 C.F.R. Part 101), must submit FERC Form 1 (18 C.F.R. § 141.1), and FERC Form 3-Q (18 C.F.R. § 141.400).

Note: Major means having, in each of the three previous calendar years, sales or transmission service that exceeds one of the following:

- (1) one million megawatt hours of total annual sales,
- (2) 100 megawatt hours of annual sales for resale,
- (3) 500 megawatt hours of annual power exchanges delivered, or
- (4) 500 megawatt hours of annual wheeling for others (deliveries plus losses).

III. What and Where to Submit

(a) Submit FERC Forms 1 and 3-Q electronically through the forms submission software. Retain one copy of each report for your files. Any electronic submission must be created by using the forms submission software provided free by the Commission at its web site: <http://www.ferc.gov/docs-filing/eforms/form-1/elec-subm-soft.asp>. The software is used to submit the electronic filing to the Commission via the Internet.

(b) The Corporate Officer Certification must be submitted electronically as part of the FERC Forms 1 and 3-Q filings.

(c) Submit immediately upon publication, by either eFiling or mail, two (2) copies to the Secretary of the Commission, the latest Annual Report to Stockholders. Unless eFiling the Annual Report to Stockholders, mail the stockholders report to the Secretary of the Commission at:

(d) For the CPA Certification Statement, submit within 30 days after filing the FERC Form 1, a letter or report (not applicable to filers classified as Class C or Class D prior to January 1, 1984). The CPA Certification Statement can be either eFiled or mailed to the Secretary of the Commission at the address above.

The CPA Certification Statement should:

- a) Attest to the conformity, in all material aspects, of the below listed (schedules and pages) with the Commission's applicable Uniform System of Accounts (including applicable notes relating thereto and the Chief Accountant's published accounting releases), and
- b) Be signed by independent certified public accountants or an independent licensed public accountant certified or licensed by a regulatory authority of a State or other political subdivision of the U. S. (See 18 C.F.R. §§ 41.10-41.12 for specific qualifications.)

- b) FERC Form 3-Q for each calendar quarter must be filed within 60 days after the reporting quarter (18 C.F.R. § 141.400).

V. Where to Send Comments on Public Reporting Burden.

The public reporting burden for the FERC Form 1 collection of information is estimated to average 1,144 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data-needed, and completing and reviewing the collection of information. The public reporting burden for the FERC Form 3-Q collection of information is estimated to average 150 hours per response.

FNO - Firm Network Service for Others. "Firm" means that service cannot be interrupted for economic reasons and is intended to remain reliable even under adverse conditions. "Network Service" is Network Transmission Service as described in Order No. 888 and the Open Access Transmission Tariff.

LFP - for Long-Term Firm Point-to-Point Transmission Reservations. "Long-Term" means one year or longer and "firm" means that service cannot be interrupted for economic reasons and is intended to remain reliable even under adverse conditions. "Point-to-Point Transmission Reservations" are described in Order No. 888 and the Open Access Transmission Tariff. For all transactions identified as LFP, provide in a footnote the

termination date of the contract defined as the earliest date either buyer or seller can unilaterally cancel the contract.

OLF - Other Long-Term Firm Transmission Service. Report service provided under contracts which do not conform to the terms of the Open Access Transmission Tariff. "Long-Term" means one year or longer and "firm" means that service cannot be interrupted for economic reasons and is intended to remain reliable even under adverse conditions. EXCERPTS FROM THE LAW

Federal Power Act, 16 U.S.C. § 791a-825r

Sec. 3. The words defined in this section shall have the following meanings for purposes of this Act, to with:

(3) 'Corporation' means any corporation, joint-stock company, partnership, association, business trust, organized group of persons, whether incorporated or not, or a receiver or receivers, trustee or trustees of any of the foregoing. It shall not include 'municipalities, as hereinafter defined;

(4) 'Person' means an individual or a corporation;

(5) 'Licensee, means any person, State, or municipality Licensed under the provisions of section 4 of this Act, and any assignee or successor in interest thereof;

(7) 'municipality means a city, county, irrigation district, drainage district, or other political subdivision or agency of a State competent under the Laws thereof to carry and the business of developing, transmitting, unitizing, or distributing power;

(11) "project' means. a complete unit of improvement or development, consisting of a power house, all water conduits, all dams and appurtenant works and structures (including navigation structures) which are a part of said unit, and all storage, diverting, or fore bay reservoirs directly connected therewith, the primary line or lines transmitting power there from to the point of junction with the distribution system or with the interconnected primary transmission system, all miscellaneous structures used and useful in connection with said unit or any part thereof, and all water rights, rights-of-way, ditches, dams, reservoirs, Lands, or interest in Lands the use and occupancy of which are necessary or appropriate in the maintenance and operation of such unit;

"Sec. 4. The Commission is hereby authorized and empowered

(a) To make investigations and to collect and record data concerning the utilization of the water 'resources of any region to be developed, the water-power industry and its relation to other industries and to interstate or foreign commerce, and concerning the location, capacity, development -costs, and relation to markets of power sites; ... to the extent the Commission may deem necessary or useful for the purposes of this Act."

"Sec. 304. (a) Every Licensee and every public utility shall file with the Commission such annual and other periodic or special* reports as the Commission may be rules and regulations or other prescribe as necessary or appropriate to assist the Commission in the -proper administration of this Act. The Commission may prescribe the manner and FERC Form in which such reports salt be made, and require from such persons specific answers to all questions upon which the Commission may need information. The Commission may require that such reports shall include, among other things, full information as to assets and Liabilities, capitalization, net investment, and reduction thereof, gross receipts, interest due and paid, depreciation, and other reserves, cost of project and other facilities, cost of maintenance and operation of the project and other facilities, cost of renewals and replacement of the project works and other facilities, depreciation, generation, transmission, distribution, delivery, use, and sale of electric energy. The Commission may require any such person to make adequate provision for currently determining such costs and other facts. Such reports shall be made under oath unless the Commission otherwise specifies*.10

"Sec. 309. The Commission shall have power to perform any and all acts, and to prescribe, issue, make, and rescind such orders, rules and regulations as it may find necessary or appropriate to carry out the provisions of this Act. Among other things, such rules and regulations may define accounting, technical, and trade terms used in this Act; and may prescribe the FERC Form or FERC Forms of all statements, declarations, applications, and reports to be filed with the Commission, the information which they shall contain, and the time within which they shall be filed..."

General Penalties

The Commission may assess up to \$1 million per day per violation of its rules and regulations. *See* FPA § 316(a) (2005), 16 U.S.C. § 825o(a).

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

ORGANIZATION

In 2009, AEPTCo formed OHTCo to build, own and operate transmission facilities in Ohio. OHTCo is a member of PJM. Upon approval of FERC rates, OHTCo began recognizing PJM revenues in July 2010.

AEPSC and other AEP subsidiaries provide services to OHTCo through service agreements. OHTCo does not have employees.

AEPTCo owns all of OHTCo's outstanding equity. OHTCo does not have outstanding debt. All of OHTCo's capital needs are provided by AEP subsidiaries. OHTCo's outstanding payables related to this funding are reflected in Notes Payable to Associated Companies and Accounts Payable to Associated Companies.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Rates and Service Regulation

OHTCo's rates are regulated by the FERC. FERC formula rates are established each July based on prior calendar year's financial activity and projected plant balances. The FERC regulates OHTCo's, AEPSC's and AEPTCo's affiliated transactions, including AEPSC's and AEPTCo's intercompany billings at cost under the 2005 Public Utility Holding Company Act and the Federal Power Act. The FERC also has jurisdiction over the issuances and acquisitions of securities of OHTCo, the acquisition or sale of certain utility assets and mergers with another electric utility or holding company. The FERC is permitted to review and audit the relevant books and records of OHTCo.

Basis of Accounting

OHTCo's accounting is subject to the requirements of the PUCO and the FERC. The financial statements have been prepared in accordance with the Uniform System of Accounts prescribed by the FERC. The principal differences from GAAP include:

The requirement to report deferred tax assets and liabilities separately rather than as a single amount.

The separate classification of income tax expense on Net Utility Operating Income and on Net Other Income and Deductions instead of as a single net income tax.

The classification of accrued taxes as a single amount rather than as assets and liabilities.

The classification of certain other assets and liabilities as noncurrent instead of current.

Cash and Cash Equivalents

Cash and Cash Equivalents on the statements of cash flows include Cash, Working Fund and Temporary Cash Investments on the balance sheets with original maturities of three months or less.

Accounting for the Effects of Cost-Based Regulation

As a cost-based rate-regulated entity, OHTCo's financial statements reflect the actions of regulators that result in the recognition of certain revenues and expenses in different time periods than enterprises that are not rate-regulated. Under OHTCo's formula rate mechanism and in accordance with "Regulated Operations" accounting guidance, OHTCo records regulatory assets (deferred expenses) and regulatory liabilities (future revenue reductions or refunds) to reflect the economic effects of regulation by matching expenses with their recovery through regulated revenues and income with its passage to customers through the adjustment of regulated revenues.

Use of Estimates

The preparation of these financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. These estimates include, but are not limited to long-lived asset impairment, the effects of regulation, long-lived asset recovery and the effects of contingencies. The estimates and assumptions used are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements. Actual results could ultimately differ from those estimates.

Accounts Receivable

Accounts receivable includes receivables from PJM based on the monthly allocation of the tariff rates that were authorized in the FERC order and receivables for sales to miscellaneous customers.

Transmission Property

Transmission property is stated at its original purchase cost. OHTCo provides for depreciation of transmission property on a straight-line basis over the estimated useful lives of property, using the group composite method of depreciation. OHTCo's composite depreciation rates are based on the PUCO's approved rates.

Asset Retirement Obligations (ARO)

OHTCo has identified, but not recognized, ARO liabilities related to electric transmission assets, as a result of certain easements on property on which assets are owned. Generally, such easements are perpetual and require only the retirement and removal of assets upon the cessation of the property's use. The retirement obligation is not estimable for such easements since OHTCo plans to use its facilities indefinitely. The retirement obligation would only be recognized if and when OHTCo abandons or ceases the use of specific easements, which is not expected.

Allowance for Funds Used During Construction (AFUDC)

AFUDC represents the estimated cost of borrowed and equity funds used to finance construction projects that are capitalized and recovered through depreciation over the service life of the transmission property.

Valuation of Nonderivative Financial Instruments

The book values of accounts receivable and accounts payable approximate fair value because of the short-term maturity of these instruments.

Revenue Recognition

Regulatory Accounting

OHTCo's financial statements reflect the actions of regulators that can result in the recognition of revenues and expenses in different time periods than enterprises that are not rate-regulated. Regulatory assets (deferred expenses) and regulatory liabilities (deferred revenue reductions or refunds) are recorded to reflect the economic effects of regulation by matching expenses with their recovery through regulated revenues in the same accounting period and by matching income with its passage to customers in cost-based regulated rates.

When regulatory assets are probable of recovery through regulated rates, OHTCo records them as assets on its balance sheet. OHTCo tests for probability of recovery at each balance sheet date or whenever new events occur. Examples include the issuance of a FERC order or passage of new legislation. If it is determined that recovery of a regulatory asset is no longer probable, OHTCo writes off that regulatory asset as a charge against income.

Transmission Revenue Accounting

In January 2010, the FERC approved an order for the AEP East Transmission companies to be included in the Open Access Transmission Tariff (OATT) administered by PJM. The FERC order suspended the effective date of the rates until July 1, 2010. The FERC order implemented an annual transmission revenue requirement for each of the AEP East Transmission companies. Under this requirement, AEPSC, on behalf of the AEP East Transmission companies, makes annual filings in order to recover prudently incurred costs (including amortization of the formation cost regulatory asset) and an allowed return on plant in service. An annual formula rate filing is made for each calendar year using estimated costs, which is used to determine the billings to PJM ratepayers. The annual rate filing is compared to actual costs with any over or under-recovery being trued-up with interest and recovered in a future year's rates.

Income Taxes

OHTCo uses the liability method of accounting for income taxes. Under the liability method, deferred income taxes are provided for all temporary differences between the book and tax basis of assets and liabilities which will result in a future tax consequence.

When the flow-through method of accounting for temporary differences is reflected in regulated revenues (that is, when deferred taxes are not included in the cost of service for determining regulated rates), deferred income taxes are recorded and related regulatory assets and liabilities are established to match the regulated revenues and tax expense.

OHTCo accounts for uncertain tax positions in accordance with the accounting guidance for "Income Taxes." OHTCo classifies interest expense or income related to uncertain tax positions as interest expense or income as appropriate and classifies penalties as Penalties.

Subsequent Events

Management reviewed subsequent events through April 17, 2012, the date that OHTCo's 2011 FERC Form 1 was issued.

2. RATE MATTERS

OHTCo is involved in rate and regulatory proceedings at the FERC. This note discusses rate matters and related regulatory proceedings that could have a material effect on OHTCo's results of operations, financial position and cash flows.

FERC Rate Matters

2010 Transmission Rate Filing

In May 2010, AEPSC, on behalf of the AEP East Transmission companies, filed OHTCo's annual transmission revenue requirement with the FERC and PJM for the period July 2010 through June 2011, which established a projected revenue requirement of \$1.8 million. PJM implemented these rates in July 2010, subject to refund and true-up. In September 2010, a settlement agreement was filed with the FERC which revised OHTCo's PJM revenue requirement to \$1.6 million and included an 11.49% return on equity for transmission investments within PJM. Due to the settlement agreement, rates were reduced to \$1.6 million in November 2010, subject to refund and true-up. In April 2011, the FERC approved the settlement agreement as filed. Under the formula rate, an annual update to the transmission revenue requirement was filed and effective July 2011 and each year thereafter. The annual update also included an adjustment to true-up the prior year's collections to the prior year's actual costs.

2011 Transmission Rate Filing

In May 2011, AEPSC, on behalf of the AEP East Transmission companies, filed OHTCo's annual transmission revenue requirement with the FERC and PJM for the period July 2011 through June 2012, which established a projected revenue requirement of \$10 million offset by \$583 thousand of prior year over-recovery of revenues, including carrying charges. PJM implemented these rates in July 2011, subject to refund and true-up.

4. COMMITMENTS, GUARANTEES AND CONTINGENCIES

OHTCo is subject to certain claims and legal actions arising in its ordinary course of business. In addition, OHTCo's business activities are subject to extensive governmental regulation related to public health and the environment. The ultimate outcome of such pending or potential litigation cannot be predicted. For current proceedings not specifically discussed below, management does not anticipate that the liabilities, if any, arising from such proceedings would have a material adverse effect on the financial statements.

Commitments

OHTCo has construction commitments to support its operations. In managing the overall construction program and in the normal course of business, AEPSC provides project development services and OHTCo contractually commits to third-party construction vendors for certain material purchases and other construction services. Management forecasts approximately \$206 million of construction expenditures, excluding equity AFUDC, for 2012. OHTCo purchases materials, supplies, services and property, plant and equipment under contract as part of its normal course of business. Certain supply contracts contain penalty provisions for early termination.

AEP System Tax Allocation Agreement

OHTCo joins in the filing of a consolidated federal income tax return with its affiliates in the AEP System. The allocation of the AEP System's current consolidated federal income tax to the AEP System companies allocates the benefit of current tax losses to the AEP System companies giving rise to such losses in determining their current tax expense. The tax benefit of the Parent is allocated to its subsidiaries with taxable income. With the exception of the loss of the Parent, the method of allocation reflects a separate return result for each company in the consolidated group.

Federal and State Income Tax Audit Status

The IRS examination of 2010 started in October 2011. Although the outcome of tax audits is uncertain, in management's opinion, adequate provisions for federal income taxes have been made for potential liabilities resulting from such matters. In addition, OHTCo accrues interest on these uncertain tax positions. Management is not aware of any issues for open tax years that upon final resolution are expected to have a material effect on net income.

OHTCo and other AEP subsidiaries file income tax returns in various state and local jurisdictions. These taxing authorities routinely examine the tax returns and OHTCo and other AEP subsidiaries are currently under examination in several state and local jurisdictions. Management believes that previously filed tax returns have positions that may be challenged by these tax authorities. However, management believes that adequate provisions for income taxes have been made for potential liabilities resulting from such challenges and that the ultimate resolution of these audits will not materially impact net income.

Uncertain Tax Positions

OHTCo recognizes interest accruals related to uncertain tax positions in interest income or expense as applicable and penalties in Penalties in accordance with the accounting guidance for "Income Taxes." For the years ended December 31, 2011 and 2010, OHTCo did not have any uncertain tax positions.

Federal Tax Legislation

In December 2011, the U.S. Treasury Department issued guidance regarding the deduction and capitalization of expenditures related to tangible property. The guidance was in the form of proposed and temporary regulations and generally is effective for tax years beginning in 2012. These regulations did not have an impact on net income or cash flows in 2011. Management is still evaluating the impact these regulations will have on future periods.

6. LEASES

Leases of property, plant and equipment are for periods up to 2 years and require payments of related property taxes, maintenance and operating costs. The majority of the leases have purchase or renewal options and will be renewed or replaced by other leases.

Affiliated Transmission Revenues

For the years ended December 31, 2011 and 2010, affiliates of AEP, that are load serving entities within the PJM region, incurred \$4.3 million and \$784 thousand, respectively, in PJM network integration transmission services related to OHTCo that were billed to them in accordance with the OATT and Transmission Agreement. OHTCo recorded these affiliated transmission revenues in Operating Revenues.

Services Provided by AEP Subsidiaries

AEPSC provides certain managerial and professional services to AEP's subsidiaries. AEP is the sole equity owner of AEPSC. The costs of the services are based on a direct charge or on a prorated basis and billed to the AEP subsidiaries at AEPSC's cost. No AEP subsidiary has provided financial or other support outside of the reimbursement of costs for services rendered. AEPSC finances its operations through cost reimbursement from AEP subsidiaries. There are no other terms or arrangements between AEPSC and any other AEP subsidiary that could require additional financial support from an AEP subsidiary or expose them to losses outside of the normal course of business. AEPSC's billings are subject to regulation by the FERC. In the event AEPSC would require financing or other support outside the cost reimbursement billings, this financing would be provided by AEP.

The billings for services are made at cost and include no compensation for a return on investment.
