Changes: On March 7, 2012, AEP Retail Energy Partners LLC acquired 100 percent of the issued and outstanding stock of BlueStar Energy Holdings, Inc., resulting in AEP Retail Energy Partners LLC becoming an upstream indirect owner of BlueStar. AEP Retail Energy is wholly-owned by AEP C&I Company, LLC, which is wholly-owned by American Electric Power Company, Inc. (collectively, "AEP entities").

On June 29, 2012, Blue Star Energy Services, Inc. dba BlueStar Energy Solutions changed its corporate name to AEP Energy, Inc.

AEP Energy, Inc. changed its principal address in December 2012.

On January 1, 2013, the direct parent of AEP Energy, Inc. changed from BSE Holdco, LLC to BlueStar Energy Holdings, Inc., BSE Holdco's parent company.


