Changes: On October 1, 2012, Exelon Energy Company merged with and into an affiliate, Constellation NewEnergy, Inc. ("CNE") with CNE the surviving entity. See the October 12, 2012 notice letter submitted to the Commission for additional detail on this transaction. CNE followed up this notice with a formal abandonment application for withdrawal of Exelon Energy's CRES certificate on December 21, 2012 in Case No. 12-3287-EL-ABN. Exelon Energy's Certificate Number 00-006E(6) was cancelled on January 9, 2013. Data for October 1, 2012 through December 31, 2012 is included in the parallel filing for Constellation NewEnergy, Inc.
