Changes: In 2014, Dominion Retail, Inc. ("DR") exited the retail electricity business nationwide. Pursuant to the requirements of Rule 4901:1-21-11(D)(1), Ohio Administrative Code, on March 18, 2014, DR provided notice to applicable Commission Staff of the assignment by DR of all of DR's former Ohio retail electricity customers to Reliant Energy Northeast LLC. DR also provided the requisite notice to affected customers required by this Rule. Presently DR no longer provides CRES service to any Ohio customer.
