On January 14, 2015, the Federal Energy Regulatory Commission issued an order in Docket No EC15-49-000 authorizing the disposition of jurisdictional facilities resulting from the sale of 100 percent of the equity membership interests in Source Power & Gas LLC's parent company, SPG Energy Group LLC, to ERM Business Energy LLC. Pursuant to Ohio Adm. code 4901:1-24-11 regarding a material change to business operations, we filed a letter on January 29, 2015, to advise The Public Utilities Commission of Ohio of this transaction that was consummated on January 22, 2015.
