Item 6
Valuation Charges

A. Valuation charges provided for in this Item will apply, unless the shipper expressly releases the shipment to a value not to exceed sixty (60) cents per pound per article

On shipments expressly released to a value exceeding sixty (60) cents per pound per article, the following charges will apply:

1. On all shipments moving subject to Replacement Value Protection:

For each \$100.00, or fraction thereof, or released or declared value.....*\$1.00 per each \$100.00

Option A- \$250.00 Deductible

When the shipper assumes liability for the first \$250.00 of any claim for which the carrier is liable, the rate shall be.....*\$.75 per each \$100.00

Valuation Charges

Option B - \$500.00 Deductible

When the shipper assumes liability for the first \$500.00 of any claim for which the carrier is liable, the rate shall be.....*\$.50 per each \$100.00

B. On shipments which are involved in Storage-In-Transit, the following additional valuation charge, to be based on the type of coverage specified by the shipper for the move, the rate shall be:

For each storage period of 30 days, or fraction thereof, an additional valuation rate of 15% of the applicable Storage-In-Transit rate as provided for in Item 4, or as amended, will apply.

C. On shipments which involve Permanent or Temporary Local Storage, the following additional valuation coverage, to be based on the type of coverage specified by the shipper for the move to Local Storage, the rates shall be:

For each storage period of 30 days, or fraction thereof, an additional valuation rate of 15% of the applicable local storage rate as provided for in the Item 4, or as amended, will apply.

Note 1. If the shipper wishes to avoid the additional valuation charges, they must agree that if any articles are lost or damaged, the carrier's liability will not exceed sixty (60) cents per pound for the article weight of any lost or damaged articles in the shipment.

Note 2. If the shipper expressly releases the shipment valuation to Replacemnet Value Protection, they declare a total replacemnet value of their choice or at a minimum of six dollars per pound times the estimated weight of the shipment, whichever is greater. The shipper understands that the total reimbursements for lost or damaged goods shall not exceed the declared value.
